## **PROTECTION OF PERSONAL DATA**

### **1. PARTY RESPONSIBLE FOR DATA PROCESSING**

Your personal data will be processed by FC Barcelona, located at Avinguda Aristides Maillol s / n, 08028, Barcelona and with Spanish tax identification number (NIF) G-08266298.

### **2. PURPOSES**

The data shall be processed for the purposes of conducting all procedures and communications that are deemed adequate or necessary for holding entrance trials and in the case of them being passed, any other activity related to the FC BARCELONA Skating School.

Likewise, and as long as you have given us your consent by checking the respective boxes, we may process your data to:

- Send you the newsletter of the Barça Fans programme, which will always be personalized and adapted to your interests.
- Send you additional information related to FC Barcelona, such as, for example, opinion polls, invitations to events, or Club products such as discounts or promotions for match tickets, merchandising, digital products, etc.
- Send you information, discounts or promotions from third parties with which FC Barcelona might have a commercial or collaborative relationship, such as, for example, the FC Barcelona Foundation and club sponsors, who are entitled to conduct actions specifically aimed at Barça Fans.

### **3. DATA COMMUNICATION**

Your data will not be transferred, sold, leased or made available in any other way to any third party, except to any FC Barcelona service providers that perform certain activities for the Club (such as, for example, sending the newsletter), but under no circumstances shall they process the data for their own purposes. Some of these suppliers may be located outside of the European Union, as indicated in this policy.

If you wish to receive information from third parties, such as the FC Barcelona Foundation or Club sponsors, this information will always be sent by FC Barcelona, and we will not provide these third parties with any data unless you have issued your express consent for this to be done.

### **4. AUTOMATED DECISIONS AND CREATION OF PROFILES**

For some services, we may process your personal data using automated means. This means that certain decisions are made automatically without human intervention. For example, you may be segmented according to whether you have an interest in certain sections of FC BARCELONA, or use our services such as, for example, free Wi-Fi on our premises.

Likewise, we may also create a profile by analysing your browsing behaviour on the web, thereby showing you products that may be of interest to you, based on the preferences you have revealed through your browsing, or information obtained by cookies.

In addition, if you have agreed to receive commercial announcements, these may be adapted and customised in accordance with users' interests, either based on the products and services requested, or based on the data that we can deduct or obtain from your browsing, interest in certain contents, reactions to our communications, among others.

This customisation is performed in a partially automated manner, in the sense that the Club determines the parameters of the customisation, but it is the technological platform that generates the user's profile. We do not send general communications that are not segmented by the previous procedure, as we consider it to be in the interest of both the Club and the user of the Barça Fans programme for information to only be sent or received if it is relevant, and because not segmenting would not alter the number of communications received from the Barça Fans programme, but only their content. If any user of the Barça Fans programme does not wish to be segmented in this manner, they are kindly requested to refrain from subscribing to the Barça Fans programme's communications..

### **5. INTERNATIONAL TRANSFERS**

FC Barcelona, as an international entity, has international providers who may offer their services outside of the EU, meaning that it is possible that your data may be used outside the European Union or the European Economic Area (for example, the provider sending out the newsletter, data storage, handling of enquiries or member services etc.)

In any case, the club guarantees that said data processing will always be protected by relevant guarantees, which may include:

- Standard Clauses approved by the EU: These include contracts approved by the European regulatory body, offering sufficient guarantees that the processing of data complies with the requirements established by European Data Protection Regulations.
- Third party certifications: For example, Privacy Shield, the framework agreement between the EU and the USA that establishes a standard framework for the processing of data pursuant to the requirements of the European Data Protection Regulation.

## 6. DURATION OF DATA PROCESSING

All the data that you provide to us will be processed for as long as you have a connection with the Skating School and that the said data is of interest to FC BARCELONA. Likewise, if you have subscribed to our newsletter, we shall process your data until the Club considers that, by any means available according to the technology available at any time, that you no longer have an interest in its products. In any case, you may unsubscribe from the newsletter at any time.

After the term indicated in the first paragraph of this section, FC Barcelona shall conserve your data, which shall be duly anonymised, for statistical purposes or market studies, whenever possible, or it shall be duly blocked to comply with any of the Club's legal obligations.

## 7. EXERCISE OF YOUR RIGHTS

At any time you may withdraw your consent to any of the treatments indicated above.

## IMAGE RIGHTS

## OBSERVATIONS

1. Completion of this application form supposes acceptance of the Ice Rink Regulations, as well as the rights, obligations and prohibitions established within the same.
2. Anyone who enters the ice rink understands and accepts that ice skating is a risky sport and/or activity, so they are obliged to respect, at their own responsibility, the regulations established for such a purpose.
3. The consumption of alcoholic beverages by minors is strictly forbidden, as is smoking inside the Ice Rink building where the different courses and activities are held.
4. Courses will be run in accordance with the programme established by the management of the Skating School.
5. Courses will be run in accordance with the programme established by the management of the Skating School.
6. Payment for courses and the enrolment fee must be made before the same commence.
7. Payment for the course earns the right a) to one hour (1 hr.) of class a week and b) skate hire. Pupils will also get free entry to all public skating sessions throughout the duration of the course for which they are enrolled.
8. Failure to attend one (1) or more classes implies no right a) for the amount paid to be returned, b) or for classes not attended to be recovered at a later date
9. If the minimum number of pupils for a class is not reached, the course may be suspended, and any payments made by the applicant will be returned.
10. The parents and/or legal guardians of minors may not be at rink level while the classes are going on.
11. The pupil, and his/her parents, guardians or companions agree to behave properly, and shall act correctly and respectfully at all times towards the pupils and teachers and agree not to interrupt the classes while they are in progress.
12. One (1) diploma will be presented to all pupils as certification of: a) their attendance of the complete course and b) the level achieved as determined by the final aptitude tests.
